### **From the Desk of the TCH President, Gary L. Stading, Ph.D.**

I would like to speak with you about a topic that is near and dear to my heart - education. I am not necessarily referring to education in the formal sense of the word (although I am a believer in formal education), but rather in the context of lifelong learning. As professionals in the transportation industry, I believe it is important for everyone in the industry to strive for continuous learning and improvement. It is through a passion for a continued understanding for the business that allows us (as an industry, as a country, as a community, and as individuals) to achieve sustained competitive advantage. Education and a passion for lifelong learning can reveal an economical edge over competition that is the difference in winning (in business) that might not otherwise be noticed.

Judge Ed Emmett addressed the TCH last month in the monthly luncheon speaking on the need for transportation constituents to become actively involved in providing input for state, local, and national governmental representatives. This emphasizes a need for transportation professionals to read and stay informed on the local transportation issues. If you are new to the industry and are wondering where to begin, the local transportation clubs (like TCH, ITMA, HTPA, HACA, and others) are an excellent place to start. The monthly transportation club meetings introduce speakers addressing transportation issues each month, and club publications enumerate various issues facing the industry. Local newspapers and industry publications carry regular stories that can help you stay informed facing industry issues.

Houston (and as Judge Emmett indicated – the entire Texas Gulf Coast) is uniquely positioned to take advantage of a multitude of economic developments (like the widening of the Panama Canal). However, in order to take full business advantage of these types of developments, industry professionals need to pursue information on these possibilities. This industry can often be thought of, by those outside of the industry, as old and tired industry relative to newer and sexier technological based industries (like iphones and ipads, etc.) But we know, that nothing is further from the truth. This industry, like many others, has gone and is going high tech at high rate of speed. For example, industry executives (like Jerry Nagel of Rickmers Linie and others) have worked with local, primary and secondary schools to allow students to tracks ships with satellite communications and GPS locators. The transportation industry is high tech and sexy too!

This industry does have a great many challenges and a great many of opportunities. I would like to encourage each of you and to challenge each of you to be diligent in pursuing information that will help overcome the challenges and take advantage of the opportunities. If you are looking for an introduction to both, the industry challenges and the industry opportunities, then Judge Emmett's transportation conference later this month is an excellent place to begin your lifelong learning endeavor. From that point, we here at TCH, invite each and every one of you to our monthly meetings and to become more involved in our organization where we encourage continuous learning within the industry.

**TCH Adopts Anti-Trust Statement** - In response to several requests from member's companies, TCH has adopted the following position statement which should be observed at any TCH event:

#### ANTITRUST STATEMENT

As members or participants with The Transportation Club of Houston, we need to be mindful of the constraints of antitrust laws. There shall be no discussions of agreements or concerted actions that may restrain competition. This prohibition includes the exchange of information concerning individual prices, rates, coverages, market

practices, claims settlement practices, or any other competitive aspect of an individual company's operation. Each participant is obligated to speak up immediately for the purpose of preventing any discussion falling outside these bounds.

### **Legislative Corner**

#### **FMCSA ISSUES NEW HOURS OF SERVICE RULES**

The FMCSA issued new Hours of Service (HOS) rules that become effective February 27, 2012 for some provisions and July 1, 2013 for other provisions.

The new HOS rules are not as restrictive as many thought they would be, because the new rules retained the 11-hour per day daily driving limit. Many thought that the FMCSA would reduce the number of hours by one hour per day. However, the new rule does reduce the number of hours a week that a driver can work to 70 hours in an eight day period, down from 82 hours.

The new rules also limit the "34-hour restart" to only one time in a seven day period. It also requires at least two nights' rest between the hours of 1:00 a.m. and 5:00 a.m.

One new and very important rule that carriers, drivers and others need to be familiar with is the definition of "egregious violations", which occur when trucking companies allow drivers to exceed the 11-hour driving limit by 3 hours or more. The penalty for trucking companies could be as high as \$11,000 per occurrence and the driver can be penalized as much as \$2,750.

The new rules are the result of almost a year of negotiations and six public hearings that were held across the country. As with any new rulemaking proceeding, there will be many questions and discussions regarding the impact on the industry.


