Emmett to Address Club

The TCH JANUARY LUNCHEON will be held at the Houston Club at 811 Rusk, downtown Houston, on Tuesday January 18, 2011. Networking starts at 11:30, then the program is called to order at 12:00. The speaker will be HARRIS COUNTY JUDGE ED EMMETT, a long time TCH member. Emmett was a member of the Texas

House of Representatives from 1979 to 1987, he was chairman of the Committee on Energy, a member of the Transportation Committee, and represented the state on numerous national committees relating to energy and transportation policy.

In 1989, President George H. W. Bush nominated Emmett as a Commissioner at the Interstate Commerce Commission. After being confirmed unanimously by the United States Senate, he served on the commission for three years.



Prior to becoming County Judge, Emmett founded The Emmett Company, a multi-faceted international consulting and marketing firm specializing in policies, products and services primarily related to the transportation industry. His previous private sector experience includes service as president and chief operating officer of the National Industrial Transportation League.

Judge Emmett has spoken at transportation conferences and meetings across the United States and in more than 15 countries. He was named one of the Top 20 Logistics Professionals ...continued next page


